## **ORDER**

Provisional affiliation was granted for starting the self financing B.Ed programme at Arafa Institute of Teacher Education (Unaided), Arafa Nagar, Attur P.O, Thrissur during the academic session 2004-05 with an intake of 100 students in the University Order read as first.

- 2. National Council for Teacher Education, after adoption of the new Regulations 2014, granted recognition to the institution for conducting B.Ed. of two-year duration with an annual intake of 100 students, for two basic units of 50 students each, from the academic session 2015-16 in the order read as second.
- 3. As per the University Order read as third, permission has been granted to consider the applications received from the training colleges, at the beginning of each academic year (from 2017- 18 onwards) as in the case of other courses and grant Continuation of Provisional Affiliation, without insisting orders for extension of approval from the NCTE.
- 4. Continuation of provisional affiliation was granted to the programme for the academic year 2019-20, vide the University Order read as fourth, with a total intake of 100 students.
- 5. The Principal, Arafa Institute of Teacher Education (Unaided), Arafa Nagar, Attur P.O, Thrissur, vide paper read as sixth, has submitted a request for Continuation of Provisional Affiliation to the self financing BEd programme for the academic year 2020-21 after remiting an amount of ₹143325/(Rupees one lakh forty three thousand three hundred and twenty five only) vide chalan no. 192259627 dated 31.12.2019 via SBI E chalan, towards administration and affiliation fee. The Principal has not submitted the renewal of NOC from the Govt., as insisted vide the University Order read as fifth, which is mandatory for granting continuation of provisional affiliation in respect of the programmes sanctioned to the College based on the NOC issued by the Govt. but submitted necessary documents to the effect of having applied for renewal of NOC.
- 6. Considering the matter in detail, sanction has been accorded by the Vice Chancellor, on 26.05.2020, for granting Continuation of Provisional Affiliation to the self financing B.Ed programme at Arafa Institute of Teacher Education (Unaided), Arafa Nagar, Attur P.O, Thrissur for the academic year

2020-21 as deatiled in the table below, on conditional basis subject to the submission of NOC for 2020-21.

- 7. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.
- 8. In the light of the directions of the Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form. In case of failure to prevent such instance of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- 9. As per the U.O.No. 5869/2015/Admn dated 09.06.2015, the conduct of University examinations of any sort including that of SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- 10. Affiliation granted is strictly provisional and only for the academic year 2020-21. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.
- 11. The list of colleges which have renewed their provisional affiliation, will be forwarded to the Office of the Controller of Examinations to ensure that examinations are not conducted in those colleges which do not have valid affiliation order.
- 12. Admission to the next academic year shall be made only after obtaining prior permission from the University.
